The historic 6,500 gross-square-foot residential and retail property will be delivered vacant. The building currently consists of five stories and a lower level, along with 20 feet of frontage that overlooks Bowery in the NoHo district. The former owners also secured approved Landmarks and DOB plans with developed design concepts to fully upgrade the building. These plans can be obtained upon request and work completed by the new ownership.
